- Marketing and Communications Data: Your preferences in receiving marketing from us, your communication preferences, and any feedback or review requests we may send to you following your interaction with our services.
- Cookies and Similar Technologies: Our website uses cookies and other
  tracking technologies (such as pixels and scripts) provided by Wix and third-party
  providers to enable website functionality, improve performance, and enhance

### 2. How We Use Your Information

We use your information to:

- Provide and manage our services.
